

**NOTICE OF INTENT TO ADOPT / NOTICE OF AVAILABILITY  
MITIGATED NEGATIVE DECLARATION  
for the 442 West Ocean Boulevard Project**

**This serves as the City of Long Beach's (City) Notice of Intent to adopt an Initial Study/Mitigated Negative Declaration for the 442 West Ocean Boulevard Project, prepared in accordance with the California Environmental Quality Act (CEQA), CEQA Guidelines, and local implementation procedures.**

*Name of Project:* 442 West Ocean Boulevard Project

*Project Location:* The proposed project site is located at 442 West Ocean Boulevard (between West Ocean Boulevard and West Seaside Way), within the City of Long Beach in Los Angeles County.

*Lead Agency:* City of Long Beach, 333 W. Ocean Boulevard, Long Beach, California 90802

*Project*

*Description:* The proposed project would consist of a 95-unit multi-family apartment complex on the approximately 24,000 square-foot site. The project would include a single structure that would consist of nine levels (one subterranean level and eight aboveground levels). The bottom three levels would consist of parking, and provide 153 on-site parking spaces. The apartment structure would reach a maximum height of 85 feet above West Seaside Way grade. The apartment units would include a mixture of studios, and one-, two-, and three-bedroom configurations. Additional amenities include lobby space, a fitness center, and a roof deck. Per *CEQA Guidelines* Section 15072(g)(5), the project site is not listed as a hazardous property as designated under Section 65962.5 of the Government Code.

**NOTICE IS HEREBY GIVEN THAT** the City proposes to adopt a Mitigated Negative Declaration for the above-cited project. The Mitigated Negative Declaration is based on the finding that, by implementing the identified mitigation measures, the project's potential significant adverse impacts will be reduced to a less than significant level. The reasons to support such a finding are documented by an Initial Study prepared by the City.
