

## NOTICE OF INTENT TO ADOPT A NEGATIVE DECLARATION

This serves as the City of Long Beach's (City) Notice of Intent to adopt an Initial Study/Negative Declaration for the Long Beach Conditional Use Permit Regulations Update, prepared in accordance with the California Environmental Quality Act (CEQA), CEQA Guidelines.

*Name of Project:* Conditional Use Permit Regulations Update

*Project Location:* Citywide, City of Long Beach, California

*Lead Agency:* Planning Bureau, Development Services, City of Long Beach, 333 W. Ocean Boulevard, 5<sup>th</sup> Floor, Long Beach, California 90802

*Project Description:* The proposed Conditional Use Permit Regulations Update (Project) is a Zoning Ordinance Amendment consisting of various changes to Title 21 of the Long Beach Municipal Code (Zoning Ordinance) to simplify the process and time to obtain a Conditional Use Permit. Changes include: 1) amending processes so certain land uses do not require Conditional Use Permits; 2) modernizing development standards; 3) organizing the standards in an easier-to-use format; and 4) amending the notification requirements to reduce cost and increase options.

**NOTICE IS HEREBY GIVEN THAT** the City proposes to adopt a Negative Declaration for the above-cited project. The Negative Declaration is based on the finding that the project's does will not have significant adverse impacts to the environment. The reasons to support such a finding are documented by an Initial Study prepared by the City.
